Better Service Means Better Value

Legislative Update: Executive Director George Klaetsch

Wisconsin Legislative Budget Proposal Includes Electrical Changes to Septic Systems



For WOWRA members that install septic systems, you are aware of the electrical connections that are required to ensure a POWTS is fully operational and up to code. Most, if not all of you are also aware of a series of state legislative proposals and law changes over the past decade that created some interpretational concerns of what a septic installer could and could not do from an electrical standpoint. For those that don't, here is a quick history lesson on the changes.

- In 2007, Act 63 revised 101.862(4)(g) to clarify the scope of the exemption it creates for individuals who install manufactured equipment, utilization equipment, and manufactured systems
- In 2014, Act 143 amended provisions in 2007 Act 63, specifically to clarify manufactured and utilization equipment for a system

Both WOWRA and WLWCA were heavily involved in the legislative drafting and negotiations of the 2014 legislation in hopes of ensuring those who installed the junction, pull or device box would be legally able to complete this portion of the job without having to employ an electrician to finish the job.

Unfortunately, our efforts in passing 2014 Act 143 did not fulfill our vision to ensure two utility trucks (septic installer and electrician) were not in a customer's driveway for one septic installation job. In the field, some inspectors told septic tank installers that they needed to bring in licensed electricians to complete the task of hooking up the systems to the disconnecting point. Therefore, we needed to come back in the 2015-16 legislative session to ensure septic installers were able to start and complete the job in connecting the minimal wiring necessary for a septic installation.

I am happy to report, that with the assistance of Assembly Speaker Vos, Representative Larson and legislative council, we were successful in drafting language that was included in the Joint Finance Committee version of the budget that created specific exemptions for septic and well pump installers to perform the minimal wiring for installations. The following is the language that was inserted into the current budget proposal.

Section 1. 101.862 (4) (p) of the statutes is created to read:

101.862 (4) (p) A person engaged in installing, repairing, or maintaining a private on-site wastewater treatment system, as defined in s. 145.01 (12), if the activity only involves installing or modifying a conductor going from the system's junction, pull, or device box to the nearest disconnecting point and the conductor is buried with the system.

Section 2. 101.862 (4) (q) of the statutes is created to read:

101.862 (4) (q) A person engaged in installing, repairing, or maintaining a pump for a well, as defined in s. 280.01 (6), if the activity only involves installing or modifying a conductor going from the pump's junction, pull, or device box to the nearest disconnecting point and the conductor is buried with the pump.

PLEASE NOTE – Governor Walker signed this provision into law on July 12, 2005.


